

## Australian pro bono sector

How does pro bono contribute?

Australian Pro Bono

Pro bono in law firms



Demand for legal services



Pro bono provides a 'safety net' to address unmet legal need:

- assisting individuals with issues unable to be addressed by Legal Aid, CLCs, ATSILS
- Responses to sudden changes in legal needs e.g. natural disasters
- Ongoing work for not-forprofits and charities

National Pro Bono Target for private practitioners - **35 pro bono hours** per lawyer per year

National Pro Bono Target for inhouse and government lawyers – **20 pro bono hours** per lawyer per year All large Australian and international law firms have dedicated pro bono practitioners to drive the strategy and manage the practice.

Mature pro bono sector:

- 27 dedicated pro bono partners in Australia
- 168 dedicated pro bono lawyers
- 781,000 pro bono hours collectively

Firms largely 'fill the gap' in:

- Employment law;
- Immigration;
- Administrative and constitutional law;
- Wills, probate and estates;
- Housing and tenancy;
  and
- General commercial.



## Types of pro bono assistance

#### Legal advice

 This involves providing legal advice to a vulnerable individual or charity / NFP

#### Individual

 Often provided through attendance at a virtual / in person legal clinic which can require a regular time commitment (e.g. 3 hours every 4-6 weeks)

#### **Charity / NFP**

 Corporate advice provided directly to a charity. Timeframes depend on the nature of the advice sought

#### Legal research

- This involves undertaking legal research to support the work of a charity / NFP
- Conducted through desk based research often in the form of a questionnaire / memo / report
- Projects have longer time frames (e.g. 10 hour commitment over 2-3 months)

#### Legal education / teaching

- This involves training on a legal topic or legal skills to members of a disadvantaged community
- Conducted remotely or in person depending on where participants are based and nature of the training
- Time commitment varies depending on the project

## Sourcing opportunities

#### **Finding your own**

- Pro bono referral services, e.g. Justice Connect (Vic and NSW), LawRight (QLD), LawAccess (WA), JusticeNet (SA)
- Community legal centres
- Law society pro bono schemes
- Existing charity partners

#### Partnering with a law firm

 Dedicated pro bono teams can establish and support projects with inhouse teams
